
Notice of Completion Delhi Quance Dam Micro Hydro Project

Issue Date: June 15th, 2016

GreenBug-Norfolk Waterpower Quance Dam Limited Partnership ("LP") is proposing to construct a 0.0472 megawatt or 47.2 kilowatt project in a municipality-owned park known as the Delhi Quance Park located at 230 Talbot Road in Delhi, Ontario in Norfolk County. The project would consist of installing an Archimedes screw micro hydro generator adjacent to an existing weir on Big Creek. The project is subject to a Class Environmental Assessment for Waterpower Projects ("Class EA") and is categorized as a project associated with existing infrastructure pursuant to the Class EA.



An Environmental Study Report ("ESR") has been prepared as required under the Class EA. The proposed project has been reviewed in a process consistent with the Class EA, the results of which are described in the Delhi Quance Dam Micro Hydro Project Environmental Study Report. The conclusions of the ESR indicate the project is benign, consistent with what one would expect from a small project on a small weir, utilizing existing infrastructure, with an operating regime that is run-of-the-river and that does not affect flows and levels in the watercourse.

The ESR is available for a 61 day review period although under the Class EA only a 30-day review period is required. Thus the ESR is being made available for review and comment from June 15th, 2016 through August 15, 2016.

The proponent must receive all comments in writing regarding the project and/or the ESR no later than August 15, 2016. All comments and correspondence should be mailed to the proponent at the address noted below:

Per the process outlined in the Class EA, interested parties must first attempt to resolve any outstanding issues with the proponent during the 61 day review period. In the event that issues cannot be resolved during the review period, the concerned party may make a written request to the Minister of the Environment and Climate Change at the address noted below for a Part II Order under the Environmental Assessment Act. A copy of the Part II Order request must also be sent to the proponent at the address noted above.

Requests for Part II Orders must be made in accordance with the provisions set out in the Class EA and must be received by the Minister of the Environment and Climate Change no later than August 15, 2016. Subject to responses from the public, regulatory agencies and Aboriginal communities and necessary permits, the proponent intends to proceed with construction in 2017.

Under the *Freedom of Information and Protection of Privacy Act* and the *Environmental Assessment Act*, unless otherwise stated in the submission, any personal information such as name, address, telephone number and property location included in a submission will become part of the public record files for this matter and will be released, if requested, to any person.
